Vehicle crash claims life of one

A two-vehicle crash on Highway 412 has claimed the life of a 23-year-old who was pronounced dead at the scene of the accident. The identity is being withheld pending notification of next of kin.

Local dispatchers re-

ceived the call at 4:09 a.m. reporting that two vehicles were involved. Crockett County deputies arrived on scene first and attempted to extinguish the post-crash fire while other deputies res-

cued three patients to safety. Two Air-Evac helicopters were called to respond and transport two critical patients to the trauma center. A third patient was transported by CCAS by ground to a local hospital.

According to the Sheriff's Department there was alcohol paraphernalia observed strewn about the scene.

Alamo Police Dept., Crockett County Rescue Squad, Gadsden Fire Dept., Alamo Fire Dept., Crockett County EMS, Crockett County EMA, Air-Evac Lifeteam, THP, and the Crockett County Medical

Examiner's Office all responded to the scene. This crash is being investigated by the Tennessee Highway Patrol and CIRT.

In a totally separate incident earlier around 11 p.m., deputies intercepted a vehicle going 87 mph in a 65

mph zone on Highway 412. There were five occupants in the vehicle. Officers recovered five cases of Smirnoff an a bottle of Tito's. It is illegal to release the names of juveniles involved in this type of incident. There were no injuries.

These include Community-Based Child Abuse Prevention programs and Resource Linkage staff who focus on families whose children are at risk of coming into state care. The department has also developed a Family Resource Guide to connect families to the community services they may need.

Nurses Honor Guard offers tribute to colleagues

In 2022, a group of West Tennessee nurses recognized an unfulfilled need in the nursing community. As nurse honor guard chapters were being established across the state and nation, there was no such group that covered West Tennessee other than the "Final Farewell" offered by Henry County Medical Center to its affiliated nurses.

To fill this need the West Tennessee Nurses Honor

Guard (WTNHG) officially was established on Jan. 1, 2023 to serve the counties of Benton, Carroll, Crockett, Dyer, Fayette, Gibson, Hardeman, Haywood, Lake, Lauderdale, Madison, Obion, Shelby, and Tipton. As needed the WTNHG also will serve in adjacent counties such as Humphreys. Other chapters such as the Tennessee River City and UTM Department of Nursing have since developed their own distinct coverage areas. There is an agreement among these chapters for mutual assistance when needed.

The mission of the WTN-HG is to honor the life and service of nurses who have dedicated their careers to the field of nursing. This honor is bestowed by performing the Nightingale Tribute at the time of death. Wearing historical attire including a white uniform, blue cape, and white nursing cap, chapter members perform a service lasting approximately



Cicada song – the awakening



A television personality on "The View" made headlines last week when she speculated, stupidly, that last Monday's eclipse of the sun, the New York earthquake, and the predicted emergence of two separate broods of periodical cicadas might have been caused by

global warming. Apparently, she had been watching the news, and our national media, probably in order to gin up viewers, is treating the event as a real invasion. I'm betting the woman making the ridiculous statement was reacting to stories of billions, and in some reports "trillions," of cicadas invading the country this spring. That's what dozens of news articles said, and dramatically pointed out that two different broods, one emerging from the ground next month after 13 years, and the other after 17 years, will be rising from the earth at virtually the same time.

Some articles have treated the "invasion" as a tourist attraction and have disthe cicadas," but others have posted alarming news accounts using terms like "cicadageddon" or "cicadapocalypse," and posted headlines like, "US Braces for Cicadas by the Trillions," so if you don't know anything about cicadas it's natural to be concerned, if not fearful that we are about to witness something akin to locusts rising from the smoke in the bottomless pit described to us in the Book of Revelation. One overheated newspaper writer said that they, the cicadas, ". . .will dig their way out from underground, red eyes shining, deafening song filling the air. It will be a confluence of creatures the

president." Sorry, but this invasion has been grossly over hyped. First, it's not going to happen at all in most parts of the country, West Tennessee included, and even where it is, it's not much of a problem at all.

Contrary to what you might have read, cicadas do not sting, they don't bite, and they won't chew up your garden. They won't chew on anything, because

cussed where to go to "see they don't have teeth. All they will do is suck sap out of trees and roots, and not much of that.

> Part of the confusion over them is that many people confuse cicadas with locusts. Locusts really are bad guys and can be a serious problem, but the two are actually different species of insects whose main similarities are that they both fly and make buzzing noises. Locusts are actually grasshoppers and can swarm and devastate crops, but cicadas never do that. Cicadas are actually beneficial in many ways. For example, as they die, and all will within 4 to 6 weeks, they make a great nitrogen fertilizer. They're also a great food source for birds and small animals.

You probably remember hearing locusts last summer, and nearly every summer before that; they're part of the Southern summer soundtrack. Ken Burns brilliantly used their sound repeatedly in the background in his acclaimed "The Civil War" documentary. Those sounds, however, were made by what are known as "annual cicadas." Those in the news last week, however, are "periodical cicadas," one brood of them appearing every 17 years and one every 13 years, and the two are slightly different. Annual cicadas, which appear every summer in the South, usually around July and peaking in August and September, are what you remember hearing. Periodical cicadas, however, the ones "invading" this spring, appear only in cycles, usually 13 or 17 years. These two groups of periodical cicadas that will emerge from the ground at the same time this year are what all the fuss is about.

And these periodical cicadas will emerge, this spring, all at once, almost like clockwork, when the average soil temperature at a depth of 8 inches is 64°F, which usually, around here, happens in early May or late April, and when they do, they have one goal, and one goal only, and that is to reproduce, and that horrendous buzzing that they make will be louder and more unpleasant than that of our late summer cicadas, much louder. Some have likened their sound to that of buzz saws and lawn mowers, and male cicadas make this noise trying to attract females. When they do mate, the male cicadas immediately die, and the fe-

males lay eggs, sometimes

as many as 600 of them, on twigs and branches, and then they die also. Their entire life cycles above ground are only about 4 to 6 weeks.

When the eggs hatch the emerging nymphs fall to earth and borough themselves anywhere from 6 to 18 inches in the ground, and there they feed on juices from plant roots, year after year, for either 13 or 17 years, depending on which kind they are.

According to the media, here in Tennessee none of the 17-year brood is supposed to make an appearance in our state this year, and the 13-year cohort is expected only sporadically, primarily in Middle Tennessee. The only place in America where the two broods will actually overlap is central Ohio and a small part of Iowa.

But you never know. Maybe we will see the periodical cicadas here as well. I've read that one way to predict a cicada emergence is to watch mole activity, that the vear before a brood emerges mole activity increases, and they have been tearing up my front yard going all the way back to early last fall.

Maybe the moles know more than the media does. Wouldn't surprise me at all.



Songs with road or street names in the title

I have written before about songs with girls' names in the title, and I have written about songs with colors in the title. A couple of examples in the "girls' names" category include the close harmony of the Everly Brothers who had huge hits Cathy's Clown and Wake Up Little Suzy. Don Everly wrote the former and Felice and Boudleaux Bryant wrote the latter. (Later Felice and Boudleaux wrote Rocky Top). In the "color" category you have Blue Suede Shoes, which put Jackson's own Carl Perkins on the rockabilly map, and White Christmas by Bing Cros-

This week's column is

about songs with a road or street name in the title. Do you remember The Ballad of Thunder Road by actor Robert Mitchum? It was the theme song of the movie "Thunder Road" in which Mitchum starred as bootleg driver Lucas Doolin. He would try to outrun the federal "revenuers" and deliver illegal (untaxed) white whiskey from stills in East Tennessee. Another song from the hills of North Carolina was Tobacco Road. This was written and originally recorded by John D. Loudermilk who went by the stage name Johnny Dee while he was a performer. It was said that the song is somewhat autobiographical of Loudermilk, a native North Carolinian. He had little success with recording it, but other bands covered the song and went way up the charts. The version you likely remember was

recorded in 1964 by the British band, "The Nashville Teens." If you were a fan of the band "America" you will likely remember Ventura Highway. Incidentally "America," just like "The Nashville Teens" was a British band trying to sound American. Penny Lane is another one you might recall. It's from the Beatles' album "Abbey Road."

Bob Dylan had a big hit with the funky sounding tune Positively 4th Street. "When you ain't got nothin' you got nothin' to "The Drifters" had a big hit in 1963 with On Broadway. The tune was written by the prolific songwriting team of Barry Mann and Cynthia Weil. Ms. Weil died last year. Phil Spector who died in prison three years ago played lead guitar. Gerry Rafferty, a Scott had a big hit in 1978 with Baker Street. Nat King Cole had a big hit with (Get Your Kicks on) Route 66. Paul Simon and Art Garfunkel had a hit with 59th Street Bridge Song (Feelin' Groovy). Bill Haley and the Comets (of "see you later alligator" fame) had a hit with Paper Boy (on Main Street USA). Others that deserve mention include: Blue Avenue by Roy Orbison; Main Street by Bob Seger and the Silver Bullet Band; Moon Over Bourbon Street by Sting; and Can You Tell Me How To Get To Sesame Street?

I will close with two really weird tunes in the "street name" category. The first is Sunny Goodge Street (the "g" in Goodge is silent so it's pronounced "good") by the Scottish singer/songwriter Donovan. His real name is Donovan Phillips Leitch. ute includes the laying of a white rose on the casket or given to a family member to symbolize honor and appreciation for the deceased. A Final Role Call is performed releasing them from their duties and retiring their license number. The Nightingale Lamp is extinguished, and the Nurse's Prayer is read.

If requested by the family, casket or entryway posting of the Honor Guard can be done. These services may be held at the funeral home, church, other place of worship, or graveside. The Guard's presence helps to shine a light on the nurse's dedication and helps ease mourners' grief during this time of loss. The members of the Hon-

or Guard consider it both an honor and a privilege to participate in the final services for their fellow nurses.
